UPDATE SINCE LAST MEETING

- No asphalt plant in pit. Nothing scheduled until next year at the earliest.
- BLV crusher still producing various materials. It is estimated the crusher will remain in Stoney Trail for the rest of the year and shut down in late November or early December.
- A small stripping project was started in August and was completed in early September.
- Trucks still hauling various materials to job sites around Calgary.

GENERAL

At this time the schedule is as follows:

October BLV crusher to continue producing. Trucks in and out of

the site for material sales. No asphalt plant.

November BLV crusher to continue producing. Trucks in and out of

the site for material sales. No asphalt plant.

December Winter shut down.

- Crushers working at the very bottom now.
- A stripping project may take place over the winter. This would likely be 1-2 months and work would only occur during the day time.
- Discussion about the next time there could be an asphalt plant at Stoney. This would by next spring at the earliest (May). The plant would be required to run on the natural gas line which has been in place since summer. All future plants will be required to use natural gas.
- Discussion about noise and berms. Temporary berms are used when possible to help "deflect" noise. But these berms are built out of gravel for project and are not permanent. The only permanent berms are the seeded ones located around the property boundary.
- Other noise controls were discussed such as the orientation of asphalt plants to help direct the bulk of noise away from residents. The use of tandem trucks for stockpiling. The fact that crushers are lower in the hole than they used to be.

- Early morning noise related to ashplant plant was the biggest concern for David, as they tend to start firing up around 5 6AM.
- Discussion about the most affective times for Meetings.

YOUNG OFFENDERS CENTER

- Still concerned with dust at facility for employees, offenders, and guests.
- Possible concerns at the University Research Park.
- Dust and debris beginning to be a concern as material begins to be hauled out of Stoney Trail.

ACTIONS

- BLV to complete Silica testing at YOC. The report is expected in early November.
- BLV to carefully monitor dust and debris at entrance. Need to mobilize dust control equipment as required as the truck traffic increases. This is occurring.
- BLV to send out e-mail to stakeholders any time there is a major change at the gravel pit.
- David to request guidance from local community and report back to BLV about the most desirable time of day to hold meetings.
