UPDATE SINCE LAST MEETING

- Third monitoring station installed at Young Offenders Center. Preliminary data available at meeting but not matched up against limits. Future reports will be formatted similar to existing reports.
- Design on proposed sound berm completed. Will require 80k m3 of dirt to complete. BLV preparing final cost estimate for submission to AT.
- Traffic study of pit entrance nearly completed. Opus to provide final report for next meeting.
- Currently blasting a dense conglomerate layer in the mining area. Estimate that this will be complete by end of January. Crushing plant to move in during February.
- Natural gas line installed to the SE property line at Stoney Trail. Final segment of the line will be installed in next couple of months.

GENERAL

• Discussion about Stoney Trail Schedule. At this time it appears as follows:

January	Finish drill/blast activities in order to break up
	conglomerate layer
February	BLV crusher to move into site and begin processing
March	BLV crusher continue processing
April	BLV crusher continue processing
May	Bottom mined out. BLV crusher to leave site. Stripping
	contract to begin in order to expose more mining area.
June	Stripping work to be continued
July	BLV crusher to return. Possible AT project to begin

This could change and with the economic climate being what it is, it is hard to speculate much past mid year.

- Discussion about possible concerns arising at the University research park.
- Discussion about information getting out to local residents. Strong desire for an Open House to be held at Stoney Trail once again. A spring event would seem the most logical as it could be used as a forum to let residents know what to expect in 2009.

- Still concerned with dust at facility for employees, offenders, and guests.
- Waiting for results of traffic study. YOC will monitor results from dust monitoring station as they come in.
- Brought up the possible concerns at the University Research Park.
- Not many concerns right now as there is almost zero activity at Stoney Trail right now.

- BLV to ensure that Kevin Brophy is added to e-mailing system to ensure that they receive notification of any exceedance recorded by the dust monitors at the YOC.
